## 1. Scope of Application

1.1 Defines the requirements for organizing the work of the Faculty Quality Assurance Commissions (FQAC) at Khoja Ahmed Yasawi International Kazakh-Turkish University.

1.2 This Regulation is a normative document forming the Academic Policy and the Internal Quality Assurance System of the University. All structural units are obliged to comply with its requirements.

## 4. Procedure Description

4.1 General Provisions

4.1.1 The FQAC is a collegial body responsible for organizing, implementing, and evaluating quality assurance activities at the faculty.

4.1.2 The FQAC is established to align the internal quality assurance system of the University with international standards and guidelines for quality assurance in the European Higher Education Area (ESG). (subsequent points 4.2–4.5 detail the main areas: program design and approval, student-centered teaching, admission and certification, academic staff, resources and support, information management, public communication, monitoring, external quality assurance, etc.)

## 5. Responsibility and Authority

5.1 The Director of the Academic Department is responsible for implementing the requirements of this Regulation.

5.2 Compliance with the requirements of this Regulation is monitored by the Vice-Rector for Academic and Methodological Affairs.
